Subject: 2019 Comprehensive Plan Public Hearing Notice and Procedure

Thank you for your continued interest in the 2019 Comprehensive Amendment proposals. As you know, the Planning Commission and City Council have held multiple discussions on the topic since last February. In an effort to be the most inclusive to all interested parties, the City has established the following schedule for public comment and testimony:

1. The Planning Commission will hold the Public Hearing on **October 17th** and will continue the hearing to **November 21st** for any additional testimony. This will allow sufficient time for the public to provide comment and the applicants of both Comprehensive Plan amendment proposals to provide testimony on their amendments.
2. The public and the applicants may testify and/or provide written comments at either the October 17th or November 21st meetings.
3. The applicants and commenters will have up to 10 minutes to speak.
4. If the public or applicants can't attend, they may submit written comments to the Planning Commission no later than November 21st at 5:00 pm.
