The site plan is a graphical representation of your total proposal as seen from above including property lines. The site plan should include:<ul style="list-style-type: none">• Name, address, and phone number of the person who prepared the drawing.• Graphic scale and north arrow.• Location of streets, and driveways, include driveways on adjacent property and adjacent streets.• Location of power, gas, sewer water, and telecommunication lines, paving, or any other utility improvements, where applicable. Location of frontage improvements for curb, gutter, sidewalk, catch basin.• Location of existing and proposed street trees. Identify trees proposed to be removed.• Species of tree(s) selected from the Approved Street Tree List. | <ul style="list-style-type: none"><input type="checkbox"/> Proof of License, Bonding and/or Insurance. For any work in the public right-of-way public liability insurance is required. All contractors and/or individuals must provide a certificate of liability insurance naming the City of Shoreline as additional insured.<input type="checkbox"/> Traffic Control Plan – two (2) copies: Required for <u>all</u> permit applications working within the City of Shoreline Right-of-Way. |
