Construction/Demolition Debris

Construction, demolition, and land clearing debris, also known as CDL, include materials that result from construction, remodeling, repair or demolition of buildings, roads, or other structures. It includes, but is not limited to, wood, concrete, drywall, masonry, roofing, siding, structural metal, wire, insulation and asphalt.

Recycling of Construction, Demolition and Land clearing Debris

Residents and businesses are encouraged to recycle CDL debris. All materials that are not recycled must be transported to an approved disposal site. In the City of Shoreline, CleanScapes is the only authorized solid waste transporter. If the volume of the CDL load is more than 10% garbage, CleanScapes is the only business that can haul it away. If the volume contains less than 10% garbage, any CDL recycler may haul it away. CleanScapes also provides recycling services through its sister company CDL Recycle. Disposal at Solid Waste Facilities

If a property owner is disposing materials at solid waste facilities there are several important considerations to keep in mind:

- Customers using dump bed vehicles may not dispose of CDL at Solid Waste Division transfer stations, such as the Shoreline Recyling and Transfer Station, 2300 North 165th Street (206) 296-4466 - Solid Waste
- Small amounts of CDL debris are accepted at King County transfer stations. Small amounts of CDL debris are accepted as garbage at King County transfer stations if the amount is less than 10% of the total volume of the load.

WARNING: Vermiculite Attic Insulation and other materials containing asbestos

If you have vermiculite attic insulation:

- Do not test the insulation the testing procedure for vermiculite is unreliable at this time.
- Do not attempt any project that may disturb the insulation.
- Hire a certified asbestos contractor if you must remove the insulation.

Puget Sound Clean Air regulates the removal and disposal of asbestos-laden material in our region. They provide technical assistance, lists of approved asbestos removal contactors, and permitting information.
