SHORELINE PLACE DEVELOPMENT AGREEMENT, PLN18-0206

NOTICE IS HEREBY GIVEN that the Shoreline Planning Commission will hold a public hearing on:

The purpose of the public hearing is for the Planning Commission to consider public testimony and make a recommendation to the Shoreline City Council on a Development Agreement between the City of Shoreline and the Merlone Geier Partnership, as authorized by SMC 20.30.355 and RCW 36.70B.170-210, to redevelop the previous Sears site in the center of Shoreline Place (formerly Aurora Square). The redevelopment includes removal of the existing Sears building, developing seven (7) multi-family buildings providing 1,358 residential units and two (2) commercial buildings adding 72,160 square feet of new space, public and private open space, and related public infrastructure. The Development Agreement will set forth the development standards and other provisions that shall apply to and govern and vest the development, use, and mitigation of the proposed redevelopment. The final decision on the Development Agreement will be made by the Shoreline City Council.

Interested persons are encouraged to provide oral and/or written comments regarding the above project at or before the public hearing.
