

# SEPA ENVIRONMENTAL CHECKLIST

Supplemental EIS's were issued for the 2005 Comprehensive Update as well as the 2012 Comprehensive Plan update. SEPA analysis was also conducted for the adoption of the original Development Code on 6/12/00, and subsequent non-exempt amendments to the Development Code.

SEPA analysis is conducted every year on the batch of Development Code amendments with the latest SEPA DNS being issued for the 2017 Batch on September 6, 2017.

Yes. There are a number of projects currently in review (building permits, site development permits, code enforcement) that may be affected by specific amendments in the 2018 Batch. Review of pending projects will not cease because of the amendments listed here.

The City contains areas of slopes over 40 percent in some areas, especially on the western most and eastern most portions of the City.

- c. What general types of soils are found on the site (for example, clay, sand, gravel, peat, muck)? Recent geologic mapping of King County (Booth and Wisler, 2006) identifies the City as being underlain primarily by glacially derived or glacially overridden soils.

- d. Are there surface indications or history of unstable soils in the immediate vicinity? If so, describe.

Landslide hazard areas within the City of Shoreline occur predominantly along the western perimeter of the city, where the highlands descend to Puget Sound, or within steeply incised natural drainages, such as Boeing and McAleer Creeks.

- e. Describe the purpose, type, total area, and approximate quantities and total affected area of any filling, excavation, and grading proposed. Indicate source of fill.

This proposal is not site specific.

- f. Could erosion occur as a result of clearing, construction, or use? If so, generally describe.

To address erosion and sedimentation impacts, grading and stormwater codes of agencies and municipalities require preparation of a SWPPP before grading permits are issued. Such plans are prepared based upon the requirements of the adopted Surface Water Design Manual. If the area of ground disturbance exceeds one acre, then a National Pollutant Discharge Elimination System (NPDES) permit is also required. Projects seeking NPDES permit coverage typically conform to the conditions of the Department of Ecology's (Ecology) Construction Stormwater General Permit (CSWGP), which includes implementation of an SWPPP and protocols for monitoring site discharges for compliance with water quality standards.

Minimum requirements and best management practices (BMPs) for SWPPP s are established by the Washington State Department of Ecology in the *Stormwater Management Manual for Western Washington* (Stormwater Manual; Ecology, 2012); municipalities typically adopt these minimum requirements and BMP design standards, or their equivalents, as part of their stormwater management requirements for site development. The City of Shoreline has adopted the Stormwater Manual and the *Low Impact Technical Guidance Manual for Puget Sound* (LID Manual; Washington State University and Puget Sound Partnership, 2012). The City also encourages the use of emerging technologies that are part of the Washington Department of Ecology's Technology Assessment Protocol (TAPE). These BMPs, together with the erosion and sedimentation control BMPs of the Stormwater Manual, constitute the BAS for prevention of erosion and the treatment of sediment-laden runoff.

Amendments in the 2018 batch include language that addresses Building Coverage. Staff is

suggesting that the definition of Building Coverage be amended to clarify the calculation of building coverage on a parcel.

- g. About what percent of the site will be covered with impervious surfaces after project construction (for example, asphalt or buildings)?

This is a non-project action. The City has regulations about how much a particular site may be covered by buildings and hardscape. These regulations are adjusted based on the particular zoning of a parcel.

- h. Proposed measures to reduce or control erosion, or other impacts to the earth, if any:

The City currently regulates surface water, stormwater, and erosion with the Department of Ecology Stormwater Manual for Western Washington and the Engineering Development Manual.



The City will comply with the State Department of Ecology, Fish and Wildlife, and expert analysis when new construction occurs.

2. How would the proposal be likely to affect plants, animals, fish, or marine life?

The proposed 2018 Batch would be unlikely to affect plants, animals, fish, or marine life.

Proposed measures to protect or conserve plants, animals, fish, or marine life are:

The 2018 Batch includes proposals that may impact significant trees during and after development. Amendment 24 is an amendment to allow the removal of one significant tree for every 7,200 square feet of lot area. Amendment 26 is a private proposal to retain trees within building setbacks and to require greater tree replacement for trees unlawfully damaged during construction. Amendment 27 will not count significant trees removed during the construction of City-required improvements and Amendment 28 will not require replacement of those trees removed. Amendment 29 is a private amendment to increase penalties for trees damaged or removed during construction.

3. How would the proposal be likely to deplete energy or natural resources?

The proposed 2018 Batch will not deplete natural resources.

Proposed measures to protect or conserve energy and natural resources are:

There are no new code amendments to protect or conserve energy and natural resources.

4. How would the proposal be likely to use or affect environmentally sensitive areas or areas designated (or eligible or under study) for governmental protection; such as parks, wilderness, wild and scenic rivers, threatened or endangered species habitat, historic or cultural sites, wetlands, floodplains, or prime farmlands?

There are no proposed code amendments to the Critical Area Ordinance or amendments that will affect parks, wilderness, wild and scenic rivers, threatened or endangered species habitat, historic or cultural sites, wetlands, floodplains, or prime farmlands in the 2018 Batch.

Proposed measures to protect such resources or to avoid or reduce impacts are:

The current Development Code will continue to protect resources and reduce critical area impacts.

5. How would the proposal be likely to affect land and shoreline use, including whether it would allow or encourage land or shoreline uses incompatible with existing plans?

The City updated the Shoreline Management Program in 2012 and does not anticipate any changes.

Proposed measures to avoid or reduce shoreline and land use impacts are:

There are no new proposed code amendments to avoid or reduce shoreline and land use impacts.

6. How would the proposal be likely to increase demands on transportation or public services and utilities?

The 2018 Batch will not increase demands on transportation or public services and utilities. Amendments 33, 34, and 35 will allow flexibility for the installation of frontage improvements. Amendment 33 will delete the requirement for frontage improvements when a single-family home converts to a commercial use. Amendment 34 will allow Public Works to waive frontage improvements if the project does not connect to the overall Pedestrian System Plan in the Transportation Master Plan. Amendment 35 amends driveway widths and types to better serve new types of development.

Proposed measures to reduce or respond to such demand(s) are:

There are no proposed code amendments to reduce or respond to such demands.

The proposed 2018 Batch will not conflict with local, state, or federal laws.
