Any aggrieved person may appeal this Threshold Determination and an appeal shall be filed within 14 days of issuance as provided in Chapter 20.30 SMC Subchapter 4 Land Use Hearings and Appeals. Appeals must be submitted in writing to the City Clerk with the appropriate filing fee and received no later than 5:00 pm on the last day of the appeal period. The written appeal must contain specific factual objections related to the environmental impacts of the proposal.
