ORDINANCE NO. 150

AN ORDINANCE OF THE CITY OF SHORELINE, WASHINGTON, AMENDING CHAPTERS 5.10 AND 5.15 OF THE SHORELINE MUNICIPAL CODE RELATED TO THE REGULATION OF ADULT ENTERTAINMENT BUSINESSES

WHEREAS, the City of Shoreline contracts with King County to perform licensing services on behalf of the City; and

WHEREAS, the City Council of the City of Shoreline enacted Ordinance No.'s 138 and 139, codified as Chapters 5.10 and 5.15 of the Shoreline Municipal Code, related to the licensing and regulation of adult entertainment businesses; and

WHEREAS, amending the provisions of the Municipal Code will allow the County to provide more efficient service to the City;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SHORELINE WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Amendment to Chapter 5.10 SMC, Cabarets and Adult Entertainment. Chapter 5.10 of the Shoreline Municipal Code is hereby amended as follows:

Section 5.10.040 (A)(1)(j). A complete set of fingerprints for the applicant or each applicant control person, taken by Shoreline police department employees or their designee.

Section 5.10.040 (B)(1)(a). The applicant's name, home address, home telephone number, date and place of birth, fingerprints taken by Shoreline police department employees or their designee, social security number, and any stage names or nicknames used in entertaining.

Section 5.10.040 (B)(1)(c)(v). A birth certificate issued by a state or other authorized governmental entity.

Section 5.10.080 (A). Licenses shall expire one year from the date of issue. Licenses under this chapter shall not be assignable.

Section 5.10.090(A). The Clerk may suspend or revoke any license issued under the provisions of this chapter at any time where the same was procured by fraud or false representations of fact, or for the violation of, or failure to comply with, the provisions of this chapter or the provisions of any applicable fire, building or zoning code.

Section 2. Amendment to Chapter 5.15 SMC, Panoram Devices. Chapter 5.15 of the Shoreline Municipal Code is hereby amended as follows:

Section 5.15.050 (A). The license year for licenses under this chapter shall be one year from date of issue. [Remainder of section unchanged]

Section 5.15.060 (B)(3)(j). A complete set of fingerprints for the applicant or each applicant control person, taken by Shoreline police department employees or their designee.

Section 5.15.080(A)(2). The building, structure, equipment or location of the business for which the license was issued does not comply with the requirements or standards of this chapter, or the provisions of any applicable fire, building or zoning code; or

Section 3. Amendment of Interlocal Agreement. Chapter 6.08 of the King County Code, which formerly regulated adult businesses in the City of Shoreline, is repealed. The City Manager is authorized to execute an amendment to the Interlocal Agreement between the City and the County for Regulatory Licensing of Certain Businesses in order to add the provisions of Ordinances No.'s 138 and 139 to the scope of services provided through the Interlocal Agreement.


Section 4. Severability. Should any portion of this ordinance, or its application to any person or circumstance, be declared invalid, the validity of this ordinance as a whole, or any other portion thereof, and its application to other persons or circumstances, shall not be affected.

Section 5. Effective Date. This ordinance, or a summary thereof, shall be published in the official newspaper of the City, and shall take effect and be in full force five days after the date of publication.
