## ORDINANCE NO. 68

### **AN ORDINANCE OF THE CITY OF SHORELINE, WASHINGTON, EXTENDING THE FRANCHISE AGREEMENTS BETWEEN THE CITY OF SHORELINE AND THE SHORELINE WASTEWATER MANAGEMENT DISTRICT**

WHEREAS, the Shoreline Wastewater Management District f/k/a Ronald Sewer District ("District") currently holds Franchise Nos. 7394, 6540, 6364, 476, 487, 565, 1559, and 3742 previously issued by King County, Washington to make use of streets and rights-of-way for the purposes of construction, operation, maintenance and reconstruction of sewer mains and service lines and appurtenances in, over, along, and under county roads and rights-of-way; and

WHEREAS, on August 31, 1995 the area covered by the Franchises were incorporated as part of the City of Shoreline ("City"); and

WHEREAS, the District currently operates and maintains its wastewater system in the City of Shoreline pursuant to the County Franchises; and

WHEREAS, a portion of the Districts' Franchises with the County are scheduled to expire, before negotiations between the City of Shoreline and the District concerning the Districts' franchise relationship with Shoreline reasonably could be concluded; and

WHEREAS, the District and the City wish to continue the franchise relationship on the same terms and conditions as provided in the Franchises until a new franchise is negotiated between them allowing the district to make use of streets and rights-of-way for the purposes of construction, operation, maintenance and reconstruction of a wastewater system in the City; and

WHEREAS, it is in the public interest to extend the current franchise agreements for an additional period of time,

WHEREAS, this ordinance has been passed by a majority of the City Council; NOW, THEREFORE,

**THE CITY COUNCIL OF THE CITY OF SHORELINE, WASHINGTON, DOES  
ORDAIN AS FOLLOWS:**


Section 1. All Franchise agreements between King County and the Shoreline Wastewater Management District are renewed and extended through and until negotiation and adoption by the City of Shoreline of a new franchise between the City of Shoreline and the District, or for two years from the date of this Extension Agreement, whichever first occurs, or for any period otherwise required by RCW 35.02.160.


Section 2. Directions to City Clerk. The City Clerk is hereby authorized and directed to forward certified copies of this ordinance to the franchise set forth in this ordinance. The Franchisee shall have 30 days from receipt of the certified copy of this ordinance to accept in writing the terms of the franchise granted to the franchisee in this ordinance.

Section 3. Effective Date. This ordinance shall take effect and be in full force five (5) days after the date of publication. The City Clerk is hereby directed to publish this ordinance in full.


